

**TERMS AND CONDITIONS IN RESPECT OF THE TAX FREE CALL DEPOSIT
ACQUISITION PROMOTIONAL OFFER MADE BY THE STANDARD BANK OF SOUTH
AFRICA LIMITED (“STANDARD BANK/WE/US/OUR”)**
