

**THE STANDARD BANK OF SOUTH AFRICA LIMITED (STANDARD BANK/WE/US/OUR)**  
**TERMS AND CONDITIONS (TERMS) FOR THE UCOUNT REWARDS SWEEPSOUTH**  
**COMPETITION (COMPETITION)**

*Please read the Terms carefully and pay special attention to the clauses that are in bold, as they may limit our liability (responsibility) or involve some risk to you.*

**1. DURATION**

The Competition starts at 00:00 on 3 May 2021 and ends at 23:59 on 31 July 2021 (**Competition Period**).

**2. REQUIREMENTS**

To qualify for the Competition, you must:

- 2.1.1 permanently reside in the Republic of South Africa;
- 2.1.2 be 18 years or older;
- 2.1.3 be a cardholder of a Standard Bank personal debit, credit, or cheque card (Card) which Card is in good standing (not in breach of our General Terms and Conditions and the product terms and conditions); and
- 2.1.4 be a member of Standard Bank's UCount Rewards programme which account is in Good Standing (as defined in the UCount Rewards programme terms and conditions).

**3. HOW TO ENTER**

- 3.1 Make a booking on SweepSouth's platform (Shift South (Pty) Ltd trading as SweepSouth) for a cleaning service and pay for the cleaning service using your Card or UCount Rewards Points during the Competition Period.
- 3.2 You will receive one entry for every booking made on SweepSouth's platform during the Competition Period.
- 3.3 There are no forms to fill in and once you meet the requirements set out in clause 2 above and this clause 3, you will automatically be entered into the Competition.

#### 4. **STANDARD BANK VOUCHER**

4.1 Standard Bank is offering you a voucher to the value of R100 to be used towards your first booking on SweepSouth's platform. The voucher is only valid for one use and may not be used in conjunction with any other campaigns.

6.4 These Terms apply to the Competition and all information relating to the Competition (including any promotional or advertising material that is published).

6.5 By entering the Competition, you are bound by these Terms, the terms and conditions of the UCount Rewards programme and SweepSouth's platform.

6.6 ***We reserve the right to amend these Terms.***

6.7 ***We must process your personal information to validate your entry and if you are a Prize winner, to make the Prize available to you. By entering the Competition, you consent to us processing your personal information for this purpose. If you do not consent, please do not enter the Competition.***
