

**THE STANDARD BANK OF SOUTH AFRICA LIMITED (STANDARD BANK/WE/US/OUR)
SWEEPSOUTH WORK LIFE BALANCE PROMOTION (PROMOTION)
TERMS AND CONDITIONS (TERMS)**

Important clauses, which may limit our responsibility, place an obligation on you to indemnify us, involve an acknowledgment of any fact or involve some risk for you will be in bold and italics. You must pay special attention to these clauses.

1. DURATION

The Promotion starts at 00h00 on Monday, 1st November 2021 and ends at 23h59 on Tuesday 30 November 2021 (**Promotion Period**).

2. WHO MAY ENTER

2.1 To qualify as an applicant of this Promotion you must:

2.1.1 be a permanent resident of the Republic of South Africa;

2.1.2 be over the age of 18 (eighteen) years old; and

2.1.3 book any SweepSouth service online during the Promotion Period, using the code SWEEP100SB.

(“Applicants”)

3. HOW TO QUALIFY FOR A VOUCHER

3.1 Applicants must book any service with SweepSouth during the Promotion Period using the code: SWEEP100SB.

3.2 Once an Applicant has booked a service with SweepSouth they will be provided with a code (**Voucher Code**). The Voucher Code, when presented to SweepSouth on booking a service, will entitle the Applicant to a R100 discount on the SweepSouth service.

3.3 The Voucher Code may be redeemed once per Applicant during the Promotion Period. Booking of a SweepSouth service where the Voucher Code is redeemed must take place on or before 15 December 2021. The Voucher Code may not be used in conjunction with any other promotion.

3.4 Each Applicant is only entitled to participate in the Promotion once during the Promotion Period and to receive one Voucher Code during the Promotion Period.

4. GENERAL

4.1 ***These Terms may be amended by Standard Bank at any time, with or without notice.***

4.2 We are the promoter of the Promotion. Any reference to **we/us/our** includes our directors, members, partners, sponsors, employees, agents, consultants, suppliers, contractors and sponsors, where the context allows for it.

4.3 By participating in the Promotion, you agree to be bound by:

4.3.1 these Terms.

4.4 Applicants will receive their Voucher Code by SMS no later than one day following the booking of a SweepSouth Service during the Promotion Period.

4.5 When booking a SweepSouth Service, Applicants must enter the Voucher Code in order to qualify for a discount of R100 on a booking during the Promotion Period.

4.6 If an Applicant who has received a Voucher Code does not use a Voucher Code during the Promotion Period or if an entry is not valid for whatever reason or if an Applicant has breached these Terms or if an Applicant renounces a Voucher Code, or we deem such Applicant to have renounced the Voucher Code, we reserve the right to declare the Voucher Code invalid.

4.7 The discount which applies to a booking when redeeming a Voucher Code, may not be exchanged for any other item.

- 4.8 ***All Applicants who accept and redeem a Voucher Code do so entirely at their own risk.***
- 4.9 ***We will need to process your personal information to validate your entry and if you are provided with a Voucher Code, to make the Voucher Code available to you.***
- 4.10 ***We will be entitled to publish each Applicant's name and photograph in any advertising, promotional, print, point of sale or public relations material (the nature and manner of such releases to be determined within our sole discretion), for a period of twelve months from the date of redemption of a Voucher Code. Each Applicant who redeems a Voucher Code will be given the opportunity to decline the publication of their images and to participate in our marketing material insofar as it relates to the Promotion.***
- 4.11 No entry into the Promotion will be valid until a validation process has taken place.
- 4.12 In the event of a dispute, our decision will be final and binding on all aspects of the Promotion and no correspondence will be entered.
- 4.13 ***We assume no risk and/or liability whatsoever for the failure of any technical element in the Promotion which may result in an entry not being successfully submitted and/or Applicants not successfully receiving Voucher Codes or redeeming Voucher Codes. Once an Applicant redeems a Voucher Code such redemption of a Voucher Code shall be at their own risk.***
- 4.14 ***We assume no liability whatsoever for any indirect loss, harm or damage arising from an Applicants participation in the Promotion howsoever arising. All Applicants, whilst participating in the Promotion, indemnify and hold us harmless for any loss, damage, harm, or injury (whether arising from negligence or otherwise) which may be sustained because of any claim, costs, expense, loss or damages which may be made or suffered by an Applicant or any third party.***
