

THE STANDARD BANK OF SOUTH AFRICA LIMITED (STANDARD BANK/WE/US/OUR)
TERMS AND CONDITIONS (TERMS) FOR THE UCOUNT REWARD
MOTHERS DAY STAFF SPEND/REDEEM AND WIN COMPETITION (COMPETITION)

Please read the Terms carefully and pay special attention to the clauses that are in bold, as they may limit our liability (responsibility) or involve some risk to you.

1. DURATION

The Competition starts at 00:00 on Friday, 29 April 2022 and ends at 23:59 on Tuesday, 31 May 2022 (**Competition Period**).

2. REQUIREMENTS

- 2.1.1 permanently reside in the Republic of South Africa;
- 2.1.2 be 18 years or older;
- 2.1.3 you are a permanent and/or temporary employee of Standard Bank;
- 2.1.4 you have received a communication from us to participate in this Competition;
- 2.1.5 you are a cardholder of a Standard Bank personal debit, credit, or cheque card (**Card**) which Card is in good standing at the commencement of this Competition Period;
- 2.1.6 you are an existing member of Standard Bank's UCount Retail Rewards programme (**UCount Rewards**) whose account is in Good Standing (as defined in the UCount Rewards terms and conditions).

- 5.5 ***We reserve the right to amend these Terms.***
- 5.6 ***We must process your personal information to validate your entry and if you are a Prize winner, to make the Prize available to you. By entering the Competition, you consent to us processing your personal information for this purpose. If you do not consent, please do not enter the Competition.***
